The position in accordance with Section 28 subsection 1 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG) commences on the next possible date agreed.

This is a fixed term contract in accordance with Section 2 of the academic fixed-term labor contract act (Wissenschaftszeitvertragsgesetz, WissZeitVG). The initial fixed term is three years. The position calls for 75% of standard work hours per week.\*

#### **RESPONSIBILITIES:**

Research associates will be expected primarily to teach and conduct research. The research associate will also have the opportunity to pursue further academic qualifications, in particular a doctoral dissertation. At least one-third of set working hours will be made available for the research associate's own academic work.

#### **SPECIFIC DUTIES:**

As a member of our team, you will be involved in empirical research projects and further developing them with us. We work at the thematic interfaces between innovation, management of structures and processes, and New Work (digitization and meetings). Research findings will be presented at international conferences and published in English in international journals. You will assist in developing, teaching and supervising courses of the chair, and will be responsible for teaching 3 LVS (3 teaching periods per week during each semester). You will also get involved with us in knowledge transfer with business and society. During your PhD studies, a comprehensive and international range of courses will prepare you for your dissertation project in terms of methods and content.

\* Full-time positions currently comprise 39 hours per week.

## REQUIREMENTS:

A university degree in a relevant field. You should be interested in examining scientific questions and have knowledge of at least one of our areas of focus. We are therefore looking for a highly motivated applicant with a degree in Business Administration, Economics, (Organizational) Psychology, Business Engineering, or Business Informatics. In addition, you should have excellent analytical skills, as well as the ability to write for publication. Very good language skills in English are essential. If you don't have sufficient German language skills, you should acquire them within a period of two years. Methodical experiences would be an advantage.

Beyond your professional qualifications, you are a committed and autonomous personality with a structured and independent way of working. Please also submit a one-page letter of motivation in English and the final thesis of your last degree in electronic form.

Qualified disabled candidates or applicants with equivalent status receive preference in the application process.
